Concept 8

IX. Good service leadership at all levels is indispensable for our future functioning and safety. Primary world service leadership, once exercised by the founders, must necessarily be assumed by the trustees.

Hi My name is Dan M. and I am an alcoholic.

I have been asked to write my story from a friend of mine. I have to say that I am honored and humbled to be asked to write something that means so much to me. To be able to share a piece of me with you. I was born in Philadelphia in 1979, was raised in an Irish Catholic family. I am the youngest of four, I have an older sister and older twin brothers. My father was a Philly cop and my mother was a RN for Temple University hospital. Life seemed pretty normal until the Devil knocked on my door on January 21st 1989. My brother Mike walked into a neighbors home and was shot in the face with a 357 magnum. As a young child, I heard my father scream Michael and then silence. I heard the sirens, but did not quite understand. At the time I had a broken ankle, and so alone I hopped up the basement stairs, limped around the corner only to hear and see things a nine year old should have never seen or heard. I can remember the night like it was yesterday. My neighbor scooped me up (an alcoholic), and took me to his home where I sat for what seemed like years in a child's mind. As I said the Devil knocked on my door, unfortunately for me shortly after the Devil enter into my home and stole my childhood. I was terrified and I understood the definition of the word "Fear". Alcoholism was a part of my life before I picked up my first drink, that came in the summer between 8th and 9th grade. Mad Dog 2020!! I remember the minute it went down my throat the fear was gone. I have arrived, and everyone was gonna know it. It showed quickly because the fear turned into rage. I became a raging alcoholic pretty quick and nothing was gonna stand in my way. My father had to call

the cops on me to wrestle me down. You see, being a cops son, I did what I want, but when a cop calls the cops on his own son, you are going to pay a price. With the alcohol came the drugs, the raves, the blackouts and the pain.

I managed to get sober at 19. Don't ask me how, but I stayed sober for seven years. Moved to Colorado in 2000 with five other men (two being my brothers), and made it out of Philly. Met my now ex-wife, had two kids, and starting chasing the dollar. You know the story, keeping up with the Jone's, filling my soul with anything but God, for I hated Him because of my childhood. In 2006, I went to the dentist for a simple root canal. He prescribed me twenty painkillers. I had no idea what an opiate high was, well I was soon gonna find out that it took my life. I had no defense against the first drink. I was powerless, and now I was also powerless over opiates. In 2006 the pill mill doctors were everywhere. In 2008 the Government shut the pill mills down and I was cut off. November 2008 I put my first needle in my body. Somehow I became a business agent for the International Brotherhood of Teamsters. I received a DUI in 2016, was locked up in 2017, was locked up in 2022, was fired as a business agent in 2022, was locked up in 2023. I got separated with my ex-wife in April 2022 and I just could not handle it. I took my daughter to rehab and I was free to do what I wanted to do. Three weeks before I entered Mountain Springs Recovery I sold my car for alcohol and dope, the eviction notice was on my door. I was so happy as I waited for my Uber. Showed up at the liquor store then off to the dope house. I would have done anything to bury my pain. On fathers day my daughter walked in, nobody was talking to me. I was alone and wanted to die. I asked my 19 year old for help, her being off dope for a

year simply said, "it's about time dad".

The next day I was in rehab. June 19th my life ended, but my life also finally began. Tuesday, my brother-in-law called me and asked me when the outside meeting was coming in, I told him Wednesday. He told me, Danny if you don't get a sponsor, then don't ever call me again. My brother-in-law is my inspiration. He walked out of prison with a trash bag 15 years ago and now he is sober, he is my sisters husband, he adopted all of my sisters kids and my sister is safe and happy. So on Wednesday, I walked into the meeting, shaking and detoxing and scared. I stayed after the meeting and asked this man to sponsor me, he said yes and to call him. I finally took one suggestion to heart and called him. I was terrified!!

When the cobwebs shook loose, we got busy. You see I was never doing the steps, surrender to a God that I hated, NO WAY. I was out of options. My sponsor told me before step three you need to have a talk with God, ask him the guestions you need to ask him. Well I had questions alright, and I asked Him all of them. Eventually I had no more questions, I was forced to sit there, I had nowhere to run, and I could not hide anymore. My God came to me that night, It was fierce, powerful. I could hear the ripples in the pond, the stars were eye level, I could smell the grass moving in the wind, everything was completely silent and I felt a man sitting next to me. I knew there was more work to be done. I wrote a forth step and then it was time for the dreaded fifth step. I was taking a few of my demons to the grave with me. Well I made a decision to turn my will over to God, so I made that agreement. So I let my sponsor have it, ALL OF IT. I did not want it anymore. I walked out on the balcony when were done and the heavens split. My God flowed through

my veins, I could feel the clouds kissing my nose as I took a sigh of relief. The birds sung songs of joy next to my ears, I could see angels flying in the sky above me, I felt light, like I was not on this earth anymore and for the first time I walked through an archway a free man. I finally understood the 4th dimension. I read my 6th step took my 7th step, wrote my amends and starting making them. I actually had the privilege to take another man through the steps. I started to go to school for a Certified Addiction Councilor. I quit my old job and I am now working at a rehab. I have entered a state of peace today, where I sit calmly in meditation with my God. I find myself spacing out in the clouds often and I am blessed to be alive today. I have forgiven and I am at peace with childhood. I know my experience will help someone. I want to be on the firing lines of Alcohol and Addiction for the rest of my life. I don't wanna ever leave this world for I know I have suffered enough. You see I believe I have slow danced with the Devil. I am here to tell you I am now slow dancing with my God. God bless everyone reading this and thank you all for being a part of my recovery journey.

Archives Corner

From the Area Service Office (ASO) Archives:

The Archives has many formats and editions of our basic text *Alcoholics Anonymous*. No, ASO does not have a 1st edition released April 1939. First edition printings go for thousands of dollars on the Internet. ASO does have copies of the 2nd edition including a first printing. The 2nd edition was released at the International Convention at St. Louis July 1955. We have many copies of the 3rd edition (released April 1976) and the current edition (4th) which was released in 2001. Word has it that stories for a 5th edition are being solicited.

ASO has an autographed 3rd edition by Dr. Bob's son, Smitty, donated to ASO by Sharon P. June 2010. We have Big Books signed by many people with and without inscriptions. And some signed in memory of folks who died of our disease. We have hardbound and softbound, large print and pocket editions. Study editions, facsimiles of the 1st edition, a fourth edition on cassette tapes (14 tapes in all). Pristine Big Books and heavily marked editions. I remember searchable DVD Big Books and bootleg copies on floppies. Nowadays it's easy to find searchable Big Books on the Internet.

Other than forewords to new editions, correcting typos, and changing stories, *Alcoholics Anonymous* has stayed the same. Stories from the first three editions that are not included in the 4th edition were printed by AA World Services and released January 2003 entitled *Experience, Strength and Hope*.

Supporting A.A.'s services

While contributions cover each group's rent and other expenses, the Seventh Tradition is essential to all areas of A.A. service. It is both a privilege and a responsibility for groups and members to ensure that not only their group, but also their intergroup/central office, local services, district, area, and the General Service Office remain self-supporting. The General Service Conference suggests that individual groups, through an informed group conscience, adopt a specific

contribution plan tailored to meet the group's financial situation. Once the group's expenses have been taken care of the group may decide to further carry the message by sending money to the following A.A. service entities.

- The local district, which communicates directly with the groups, providing the district group conscience for the area assemblies, and serving as a link between the area delegates and the G.S.R.s.
- The area committee, which coordinates vital A.A. activities over a broad geographic area; sends a delegate to the annual General Service Conference; holds area assemblies to determine the needs of the Fellowship; and provides information at all levels of service.
- The local intergroup or central office, which may provide phone service for Twelfth Step calls and other inquiries; coordinates group activities; and facilitates A.A. literature sales, institutions work, public information, and cooperation with the professional community activities.
- A.A.'s General Service Office, which functions as a storehouse of A.A. information, communicating with members and groups around the world; publishes A.A.'s literature; and supplies information and experience to professionals and others interested

Corrections volunteers are needed to:

- Take meetings into State and Local corrections facilities, such as community
 corrections programs, county jails and prisons. The application process that volunteers
 are required to undergo varies depending on the facility and the Corrections Committee
 is dedicated to assisting the volunteer through this process.
- Act as temporary contacts for offenders releasing into our community from state and local correctional facilities. Temporary contacts are A.A. members who agree to meet an offender, upon release from a correctional facility, at up to 3 meetings to help introduce them to and become acclimated to our local recovery community.
- Correspond with offenders currently incarcerated. Correspondence volunteers write letters to those who are incarcerated sharing their experience, strength and hope through the mail.

Minimum Requirements (El Paso County)

- 1. Must be at least 18 years of age, 21 for some positions.
- 2. Must have no felony convictions.
- 3. Must have no misdemeanor convictions in the last 3 years.
- 4. Must be off any type of probation or parole for 3 years.
- 5. Must not have had any arrests in the last 3 years.
- 6. Must not have been incarcerated or held in a detention facility for 3 years.
- 7. Must not have a close relative incarcerated at one of the El Paso County Detention Facilities
- 8. Pass a CCIC/NCIC background check

Our Twelfth Step — carrying the message — is the basic service that the A.A. Fellowship gives; this is our principal aim and the main reason for our existence. Therefore, A.A. is more than a set of principles; it is a society of alcoholics in action. We must carry the message, else we ourselves can wither and those who haven't been given the truth may die.
